ADVERTISEMENT

Applications are hereby invited to the post of Assistant Public Prosecutors from Indian nationals on contract basis, to function in the Directorate of Prosecution, Govt. of N.C.T. of Delhi on the following terms and conditions:-

1. **NUMBER OF POSTS:** The current proposal is for appointment of **50** Assistant Public Prosecutors on contractual basis. However, the number of vacancies may increase or decrease if the situation so warrants.
2. **AGE:** The candidates applying for the post should not be more than the age of 35 years on the closing Date of submission of the applicants. The upper age limit is relaxable for the following categories of candidates subject to the production of valid supporting documents:
 - i. Relaxable upto five years for SC/ST/PH Candidates.
 - ii. Relaxable upto three years for OBC Candidates.
3. **Period of contract:** The contract is for a period of six months or till further orders whichever is earlier. The contract of selected Assistant Public Prosecutors will automatically stand terminated on the completion of contract period. The said engagement on contractual basis may be terminated at any time by a month's notice given by either side and without assigning any reasons. The Government, however, reserves the right to terminate the services forthwith or before the expiry of the stipulated period of notice by making payment to him of a sum equivalent to the consolidated remuneration for the period of one month notice.
4. **ESSENTIAL EDUCATIONAL QUALIFICATION :**
 - i. A degree in law from the recognized University/Institute.
 - ii. Minimum three years experience at the Bar.

Any one not fulfilling the above conditions need not apply.

5. SELECTION CRITERIA : Selection of Candidates shall be done on the basis of their performance in the interview. The number of candidates called for the interview shall be approximately 3 times to the total number of vacancies. In case more candidates apply for the post, then only shortlisted candidates shall be called for the Interview. The short-listing of the candidates shall be done as per the objective criteria based on (a) their qualification in the requisite field (such as LLM or PhD in Law), (b) working experience, (c) actual legal practice in criminal side supported by their participation reflecting in Judgements/Order Sheets of Hon'ble Supreme Court/High Court/Subordinate Courts of criminal cases wherein candidate/applicant has appeared and attendance of candidate is categorically marked by name in the said Judgements/Order sheets in criminal matter. (Maximum five certified copies of the same be attached)

6. REMUNERATION : (a) The remuneration payable to candidates would be equal to the minimum of level 10 of Pay Matrix as per 7th CPC + DA applicable on the date of offer of the contractual appointment which will remain fixed for the purpose of calculation of monthly remuneration till the contract is valid.

(b) The selected candidates will be entitled to lump sum monthly remuneration as mentioned above and no other allowances will be admissible to them. The appointees shall also not be entitled to any benefits like PF, gratuity, seniority, promotions etc.

7. JOB REQUIREMENTS: The selected candidates would be assigned the work which is normally assigned to an Assistant Public Prosecutor, including appearing in CJM, JMFC, ACJM courts and anywhere in Govt. of NCT of Delhi for defending the State, in criminal matters/cases. To teach law in Police Training College or any other institution/organization and give advice to police in criminal cases/maintain record/statistical information of criminal cases pending in Magistrate courts. In special cases, the selected candidates can be assigned duty in any Department of Govt. of N.C.T. of Delhi with the approval of Competent Authority.

8. The selected candidates would neither have any right or claim of regular service on the basis of contractual appointment of Assistant Public Prosecutor in Directorate of Prosecution nor this service will be counted if they are selected on regular basis through UPSC.

9. The selected candidates will not be entitled to financial benefits or concessions and medical facility as admissible to Government Employees.

10. The selected candidates shall be on the whole time appointment of the Institution/ Deptt. and shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in private practice of any kind during the period of contract.

11. No travelling allowance will be allowed for joining the above contractual appointment.

12. The selected candidates will be liable for disciplinary provisions of CCS (Conduct) Rules, 1964 for professional misconduct. Apart from the provision of termination of the contract, provisions of Prevention of Corruption Act would apply to him/her, as he/she would be a public servant during the term of his/her contract.

13. The Selected candidates shall be eligible for leave of 08 days in a six months on valid medical/other grounds. No other leave will be admissible to the selected candidates.

14. The selected candidates shall have no right of private practice under any circumstances.

15. The Selected candidates shall be required to maintain discipline and absolute integrity in accordance with CCS (Conduct) Rules, 1964.

16. The working hours of the selected candidates would be the same, as are being observed by the regular Assistant Public Prosecutors. However, they would not be entitled for any earned leave etc.

17. The Educational Certificate, Character and antecedents of selected candidates shall be verified and they shall be medically examined and if anything adverse is found in the report, their candidature will be cancelled.

18. RECEIPT AND SCRUTINY OF APPLICATIONS: All the applicants are required to attach self attested copies of educational qualifications, experience, caste or any other relevant certificate alongwith the application form. Any application received without requisite documents shall be rejected summarily. The Appointing Authority reserves the right to reject any application without assigning any reason thereof. The Chief Secretary/Appointing Authority will be the final authority to decide the matter in case of any dispute arising in respect of selection procedure.

19. The applications can be submitted to the Director, Directorate of Prosecution, Room No. 172, 1st Floor, Tis Hazari Courts Complex, Delhi-110054 on the working days of the department. The last date of the submission of application form will be 30 days from the date of the publication in two Newspapers. Thus, the last date of submission of application is 23-10-2026 upto 05:00 PM. Any application submitted/received thereafter by any mode will not be entertained.
