#### International

India to chair 68th session of UN's Commission on Narcotic Drugs



#### **About News:-**

For the first time, India has been selected for the esteemed position of chair of the 68th Session of the UN Commission on Narcotic Drugs (CND), which is a major accomplishment. The chairmanship of this important forum was formally taken over by Ambassador Shambhu S. Kumaran, India's Permanent Representative to the UN in Vienna. Addressing global drug-related concerns and encouraging international cooperation on drug control measures are the main objectives of the CND, a crucial UN policymaking organisation.

# The UN Commission on Narcotic Drugs' (CND) function

❖ The CND is in charge of keeping an eye on worldwide drug trends, advising member nations on drug policy, and supervising the application of international drug treaties. It is a functional commission of the UN Economic and Social Council (ECOSOC) and acts as a governing body of the Vienna-based United Nations Office on Drugs and Crime (UNODC).

### The Leadership and Duties of India

India's new position as Chair strengthens its increasing influence in international fora. India's goal as Chair is to speak for the Global South and make sure that poor countries' opinions are heard when it comes to international drug policy debates. It is anticipated that the nation will encourage communication, advocate for fair strategies, and combine emerging economies' concerns with those of industrialised countries.

#### Priorities for the 68th Session

❖ The agenda for the 68th session will place a high priority on international cooperation to address urgent problems such substance misuse, illegal drug trafficking, and healthrelated effects. India will continue its dedication to fair, inclusive, and sustainable approaches in tackling these issues, improve access to regulated substances for scientific and medical uses, and fortify evidence-based solutions.

#### About News :-

Prashasan Gaon Ki Ore the Nation-wide campaign for Redressal of Public Grievances and Improving Service Delivery will be held in all Districts, States and Union Territories of India from 19th – 24th December, 2024. Prashasan Gaon Ki Ore is a decentralize version of Special Campaign 4.0 conducted in central Ministries/Departments and PSUs from 2nd to 31st October, 2024.



# **Key Points:-**

- In this campaign, over 700 District Collectors will be participating and officials will be visiting Tehsils and Panchayat Samiti Headquarters. This is the third time, that the Government of India will be conducting a National Campaign at Tehsil Level to address Public Grievances and Improving Service Delivery. Prashasan Gaon Ki Ore Abhiyaan will create a national movement for Good Governance that will inspire future generations.
- ❖ The Preparatory Phase of the Good Governance Week 2024 will start from





December 11-18, 2024. To launch the programme of the Good Governance Week 2024, a Portal, https://darpgapps.nic.in/GGW24, will be inaugurated on 11.12.2024. This will be a dedicated portal in which District Collectors will upload progress along with the Good Governance Practices and video clips during the Preparatory and Implementation phases.

# First cotton research centre to come up in Telangana's Adilabad



#### **About News:-**

- Two All India Coordinated Research Project (ACRIP) Centres on cotton in Telangana have been authorised by the Indian Council of Agricultural Research (ICAR).
- The two centres will be set up at Adilabad (sub-center) and Warangal (main centre).

# **Key Points :-**

- The facilities were set up since, after its bifurcation, Telangana was no longer able to participate in national cotton research coordination centres. Prof. Jayashankar Telangana State Agricultural University (PJTSAU) has thus been unable to participate in the national cotton research system for the past ten years.
- When PJTSAU officials went to ICAR to ask for permission to conduct a research program under the all-India effort, two cotton research facilities were suggested.
- The staff and funding needed to support PJTSAU's cotton research will be provided by ICAR.
- In the next fiscal year, it is expected that the centres will begin performing full-fledged research.

RBI keeps repo rate at 6.5% for 11th time in a row



#### **About News:-**

- ❖ For the eleventh time in a row since February 2023, the Monetary Policy Committee (MPC) of the Reserve Bank of India (RBI) chose to maintain the reporate at 6.5%.
- The conclusion was reached by a vote of 4:2 during the meeting that took place from December 4–6, 2024.
- ❖ Focus on Inflation Control and Economic Growth: The RBI is committed to striking a balance between inflation control and economic growth, even in the face of calls for a rate drop. The governor
- Shaktikanta Das underlined how crucial long-term pricing stability is to steady growth.





# **Key Highlights:**

- ❖ Other Important Rates: The rate for the Standing Deposit Facility (SDF) is still 6.25%.
- ❖ The bank rate and the marginal standing facility (MSF) rate stay at 6.75%.
- Neutral Position Maintained: With four members voting to maintain the stance, the RBI MPC chose to remain "neutral."
- ❖ The objective is to promote economic growth while bringing inflation into line with the 4% target.

# **Revised GDP Growth Forecast for FY25:**

- ❖ FY25 GDP growth forecast was lowered to 6.6%, down from 7.2%.
- Q3 FY25 revised to 6.8% (from 7.4%).
- Q4 FY25 revised to 7.2% (from 7.4%).
- Q1 FY26 revised to 6.9% (from 7.3%).
- Q2 FY26 forecast remains at 7.3%.

#### **Inflation Outlook:**

- CPI-based inflation for FY25 revised to 4.8% from 4.5%.
- Q3 FY25 revised to 5.7% (from 4.8%).
- Q4 FY25 revised to 4.5% (from 4.2%).
- Q1 FY26 revised to 4.6% (from 4.3%).
- ❖ Q2 FY26 projection remains at 4%.
- ❖ Food Prices and Inflation: During the October-December quarter, it is anticipated that food prices would continue to drive headline inflation.
- ❖ It is anticipated that kharif output estimates and the Rabi season will reduce the pressures of food inflation, particularly for rice and tur dal.
- Core Inflation: In October, there was an increase in core inflation, despite it still being low.
- ❖ Weak GDP Growth in Q2 FY25: After growing by 8.1% in the same quarter last year, India's GDP growth in Q2 FY25 dropped to 5.4%, the lowest level in two years.
- The mining and manufacturing industries' poor performance was the main cause of the drop.

- It won't be Silva's maiden role with the ACC, having previously functioned as the chairman of the organisation's Finance & Marketing Committee.
- Silva expressed gratitude to outgoing President Jay Shah for milestones like record commercial rights for ACC Asia Cup 2024–31 and new pathway event structures.

# **Science & Technology**

Central Marine Fisheries Research Institute develops technology for captive breeding of high-value marine ornamental fishes



#### **About News:-**

The Central Marine Fisheries Research Institute (ICAR-CMFRI), a division of the Indian Council of Agricultural Research, has created captive breeding techniques for the Azure damsel and Ornate goby, two highly prized marine decorative fish species.





- The CMFRI Vizhinjam Regional Centre is where the technologies were created.
- A medium-sized seed production facility that produces 24,000 juveniles a year may bring in about ₹12 lakh, which would make it a desirable enterprise for company owners.

# **Key Highlights:**

- Features of the species: The vivid blue and yellow azure damsel is a reef-associated fish that is endangered because of overexploitation.
- Fish have a market worth of ₹350 in India and \$15-25 elsewhere.
- ❖ Ornate Goby: a common fish in marine aquariums, distinguished by its eye-catching pectoral fins with white spots. Fish have a market worth of ₹250 in India and \$15–30 elsewhere.
- Sustainability and Conservation: By encouraging sustainable fish production, captive breeding technology will lessen the strain on wild populations and aid in the preservation of coral reef ecosystems.
- Commercial Potential: Aquarists and fish farmers can more easily implement the breeding technologies for these species since the developed seed production processes can be shared with prospective business owners.
- Application in Aquarium Industry: These species are valuable for the aquarium industry due to their beauty, behavior, and roles in tank maintenance (such as cleaning sand).

# **History:-**

- The history of International Anti-Corruption Day dates back to 31st October 2003, when the United Nations General Assembly adopted the United Nations Convention Against Corruption (UNCAC). This treaty, signed by 140 countries, entered into force on 14th December 2005.
- Recognizing the importance of promoting global awareness about the issue, the UN General Assembly designated December 9 as International Anti-Corruption Day in 2003. Over the years, this day has become a platform for sharing best practices, implementing anti-corruption policies in India and globally and strengthening international cooperation.
