- The event will be inaugurated by the Chief Minister of Odisha, Mohan Charan Majhi.
- Parakram Diwas was first celebrated on 23rd January 2021, marking the 125th birth anniversary of Netaji Subhas Chandra Bose.

SEBI Plans New System for Immediate IPO Share Sales to Curb Grey Market Trading

SEBI plans to introduce a system allowing investors to sell shares immediately after allotment in an Initial Public Offering (IPO) to curb grey market trading.





- Organised by the Association of Investment Bankers of India (AIBI).
- SEBI Chairperson Ms. Madhabi Puri Buch said if investors wish to sell their shares immediately post allotment or pre-listing, it is better to give them that opportunity in a properly organised and regulated way.
- SEBI's role is to ensure IPO documents provide sufficient data for investors to assess pricing, not to determine the right IPO price.

World Bank appointed neutral expert backs India's stand on dispute with Pakistan regarding Indus Water
Treaty.

World Bank-appointed The Neutral Expert has announced that it is competent to decide on the differences between India and Pakistan over two hydropower projects in Jammu and Kashmir, under the Indus Water Treaty. The Neutral Expert has rejected Pakistan's plea facilitate the to establishment of a Court of Arbitration to consider its concerns about the designs of the two hydroelectric power projects.

India maintained that the Neutral Expert is the only competent authority to address concerns over the projects, as per the treaty.

The disagreement centers around Kishenganga and Ratle hydroelectric power projects in Jammu and Kashmir under the Indus Water Treaty of 1960.
