Find establishment NTPC Ltd, Farakka, Establishment ID- EWBMUC000003 and apply. No, other mode of application will be accepted.

E. General Conditions:

- 1. Only Indian Nationals are eligible to apply.
- Only Candidates passed Graduate and Diploma on or after 01.04.2020 are eligible.
- 3. All qualifications should be from recognized Institutions.
- 4. As per the provisions of the Apprentices Act, 1961 as amended from time to time and the candidates who have already completed their apprenticeship or terminated their apprenticeship midway or pursuing in other organizations or in NTPC Ltd. with the same qualification level, shall not be eligible for engagement as apprentice.
- Candidates claiming to belong to any category shall necessarily have a valid EWS/OBC/ SC/ST certificate from the Competent Authority. Reservations of seats as per statutory norms of government.
- 6. The candidate should be minimum of 18 years and maximum of 27 years, as on 01.04.2024.
- 7. Depending on the requirement, the Company reserves the right to cancel/restrict/enlarge the number of seats/ cancel the advertisement if need so arises, without any further notice.
