6. Who is Lutkins?

Oliver Lutkins is a robber who resides in the little rural village of New Mullion. He easily tricks the attorney who comes to serve him with a summons, even though he lives in a small town. The driver of the hacker was Oliver Lutkins.

7. When the lawyer reached New Mullion, did 'Bill' know that he was looking for Lutkins? When do you think Bill came up with his plan for fooling the lawyer?

Lutkin never permits the attorney to travel to the place where the imaginary Lutkins is meant to be at any particular time. Bill has great tools; he can scare the lawyer about Lutkin's mother and spin tales about Lutkin's nomadic lifestyle.

9. Why do you think Lutkins' neighbors were anxious to meet the lawyer?

Neighbors of Lutkin were cautious about approaching someone who could be easily tricked. They were amused by the lawyer's predicament.

10. After his first day's experience with the hack driver the lawyer thinks of returning to New Mullion to practice law. Do you think he would have reconsidered this idea after his second visit?

Following his first day of work with the hack driver, the attorney had considered going back to New Mullion to continue practicing law. But on his second visit, he discovered that the hacker—who was indeed Lutkins—had conned him. The villagers helped Lutkins with this project. It's possible that the attorney would have changed his mind about going to work after becoming the joke of the community.

11. Do you think the lawyer was gullible? How could he have avoided being taken for a ride?

The attorney comes across as a young, inexperienced person. He's still trying to figure out how this awful world operates. He ought to have finished his studies more thoroughly before leaving for the village. If there existed a picture of Lutkin, he might have taken it. It's possible that he checked again with other people before depending on Bill. He could have waited to send Bill on his own to find Lutkin.
