4.The examinations will be conducted under CCTV Surveillance. The centre superintendents are requested to ensure that CCTV is made functional in all examination halls well in advance of the commencement of examination and to see that CCTVs are functioning throughout all sittings uninterruptedly.

5.For the project evaluation and viva-voce in Commerce stream, groups are to be formed taking minimum 24 students in a group. Evaluation and viva-voice of a group is to be completed in two hours. The project evaluation and viva-voce shall be conducted by the concerned subject teacher of the institution only. There shall be no provision of external examiner for this purpose.

6.Any omission and commission in the programme must be brought to the notice of the Controller of Examinations immediately.

7.Question papers for internal assessment are to be prepared by the concerned subject teachers strictly following the pattern given vide notification no.1805/10.05.2024 and 3416/21.09.2024 of CHSE for regular candidates registered in 2023.

8.Project work should be hand written by the students within 6 pages (A4 size paper) as assigned by the concerned subject teacher on the topic from the prescribed syllabus.
