- The three-day event, hosted by DP World, has attracted more than 5,000 industry leaders from 155 countries, representing diverse sectors of the global supply chain industry. Theme 2024 Acting today to reach the opportunities of tomorrow.



# Morgan Stanley trims India's FY25 GDP forecast to 6.7%

### **Key Points:**

- Morgan Stanley has lowered India's growth forecast for FY25 from 7 per cent to 6.7 per cent, on the back of weaker-than-expected high-frequency growth data for the second quarter, which is anticipated to grow at a slower pace of 6.3 per cent.
- Furthermore, the financial services company also maintained its forecast for FY26 and FY27 at a steady 6.5 per cent, noting that domestic demand will remain a key growth driver in the coming years.
- However, Morgan Stanley projected that growth may rebound to approximately 6.7-6.8 per cent in the second half of FY25, driven by improved agricultural output and increased government spending.

### Jyothi Surekha Vennam clinches gold medal in women's Archery compound event at GT Open

### **Key Points:**

- In Archery, Reigning Asian Games champion Jyothi Surekha Vennam clinched the gold medal in the women's compound event at the GT Open in Luxembourg.
- Competing in the GT Open for the first time, Jyothi played brilliantly throughout the tournament and secured the title with a 147- 145 win against Sarah Prieels of Belgium.
- Meanwhile, in the men's compound event, Abhishek bagged the silver medal. He fell just short of claiming gold despite scoring a perfect 150 in the final. His opponent, the legendary Mike Schlosser of the Netherlands, secured the top spot after a perfect shot in the final.



# PM Modi honoured with Guyana & Dominica's highest National Honour

### **Key Points:**

During his visit to Guyana Prime Minister Narendra Modi was conferred with the highest national award of Guyana and the Dominican Republic. Prime Minister Narendra Modi became the fourth foreign dignitary to receive Guyana's highest national award, "The Order of Excellence". President Dr Mohamed Irfaan Ali of the Cooperative Republic of Guyana conferred the award on Narendra Modi in a ceremony at Georgetown on November 19, 2024.





- Prime Minister Narendra Modi was honoured with Dominica's highest national award, the Dominica Award of Honour, by Dominican Republic President Sylvanie Burton. Burton conferred the award on the sidelines of the 2nd India-CARICOM Summit meeting held in Georgetown, Guyana, on 20 November 2024. After Queen Elizabeth of the United Kingdom (1969), Prime Minister Modi was the second foreign leader to receive the award.
- Prime Minister Narendra Modi arrived in Georgetown, Guyana, on 19 November 2024, on the last leg of his three-nation tour of Nigeria, Brazil, and Guyana from 16-21 November 2024. The Prime Minister's visit to Guyana was bilateral, and he also attended the 2nd IndiaCARICOM summit meeting.

# Arrest warrant issued against Gautam Adani in New York for alleged bribery

### **Key Points:**

A Reuters report said arrest warrants were issued in the United States for Gautam Adani and his nephew Sagar Adani, after a grand jury in New York indicted the business tycoon and seven others on charges of bribery of \$265 million (around Rs 2,029 crore) on Wednesday (November 20). Lisa H Miller, Deputy Assistant General Attorney for the Justice Department's Criminal Division, accused Adani and his associates of bribing Indian government officials and conspiring to obtain lucrative solar energy

contracts "through corruption and fraud at the expense of US investors".

According to the U.S. prosecutors' document, the SECI entered into the sale agreements with Andhr Pradesh, Odisha, Chhattisgarh, and Tamil Nadu between July and December 2021.

A US district court has found that Adani Green Energy had signed a **Power Purchasing Agreement (PPA) with SECI**, under which the Adani Group

company was supposed to supply **12 GW of solar power to SECI**.

### What is an indictment?

- According to Black's Law Dictionary, "An indictment is a formal written accusation" issued against a party charged with a crime, following a step-by-step process.
- After investigating an alleged offence, the police hand over the evidence to a public prosecutor — a lawyer representing either the state or federal government, depending on whether the accusations relate to state or federal offences.
- If the prosecutor believes a serious crime or a "felony" has been committed, she may then initiate the selection of a grand jury.

### What happens now?

In Adani's case, following the indictment, the trial will likely move to the "arraignment" stage. The judge will communicate the charges and decide whether to grant bail to the accused persons, who will, in turn, decide whether to plead guilty or not guilty in response to the charges. If they plead not guilty, the case will proceed to a jury trial.

# ICC issues arrest warrant against Israel's Netanyahu

### **Key Points:**

The International Criminal Court (ICC) has issued arrest warrants for Israeli Prime Minister Benjamin Netanyahu and his former defence minister Yoav Gallant for "crimes against humanity and war crimes". A warrant has also been issued against Hamas leader Ibrahim Al-Masri, better known as Mohammed Deif. Gallant was sacked by Netanyahu earlier in November, amid reports that the defence minister advocated an end to fighting and a deal to bring back Israeli hostages captured by Hamas. Deif, Israel claims, has been killed in an airstrike, but Hamas has neither confirmed nor denied this.

The Gaza Strip is a self-governing Palestinian territory on the eastern coast of the Mediterranean Sea. It borders Egypt on the southwest and Israel on the east and north.

#### What is the ICC?

- The ICC, headquartered in The Hague, Netherlands, was established under a 1998 treaty called the "Rome Statute". It "investigates and, where warranted, tries individuals charged
- with the gravest crimes of concern to the international community: genocide, war crimes, crimes against humanity and the crime of aggression."
- At present, 124 countries are party to the Rome Statute, including Britain, Japan, Afghanistan, and Germany. India is not a member, nor are China and the US. The ICC was established to prosecute the most heinous offences only when a country's own legal machinery was unable or unwilling to act. Unlike the International Court of Justice (ICJ), which deals with countries and inter-state disputes, the ICC prosecutes individuals. Additionally, the offences should be committed either in a country that ratified the agreement or by a national of a ratifying country. The ICC can also practise its jurisdiction over cases referred by the UN Security Council to it.
- Israel is not party to the Rome Statute, but Palestine is.



### What have Netanyahu and Gallant been accused of

- The two are accused of "war crime of starvation as a method of warfare; and the crimes against humanity of murder, persecution, and other inhumane acts."
- \* "The Chamber considered that there are reasonable grounds to believe that both individuals intentionally and knowingly deprived the civilian population in Gaza of objects indispensable to their survival, including food, water, and medicine and medical supplies, as well as fuel and
- electricity, from at least 8 October 2023 to 20 May 2024," the ICC said on its website.

# What happens once ICC issues an arrest warrant?

- The ICC's decisions are binding, but it depends on its members to ensure cooperation. Thus, if Netanyahu or Gallant were to travel to any of the 124 member states, its government would be obligated to arrest them and extradite them to The Hague.
- The ICC had earlier issued an arrest warrant for Russian President Vladimir Putin. It had then been pointed out that this would deepen his isolation from the West, as he would not be able to travel to a number of countries without risking arrest. In the case of Netanyahu more than Putin, several of his country's allies, like Germany, France, and the United Kingdom, are members of the ICC. These countries have all so far backed Israel and it is very unlikely they will arrest Netanyahu if he does travel to their shores.

# India beat China to lift their 3rd Women's Asian Champions Trophy

### **Key Points:**

The defending champion Indian women's hockey team defeated the 2024 Paris

- Olympic silver medalist China to win the 8th Women's Asian Champions Trophy 2024. With this win, India has equalled South Korea's record of winning the Trophy three times. India has previously won the title in 2016 and 2023.
- The final of the Women's Asian Champions Trophy 2024 was played at the Rajgir Hockey
- ❖ Stadium in Bihar on November 20, 2024.



- The 8th Women's Asian Champions Trophy 2024 was organised by the Asian Hockey Federation and hosted by Hockey India and the Bihar government from 11- 20 November 2024.
- Incidentally, India hosted the 7th Women's Asian Champions Trophy 2023 at Ranchi, Jharkhand, which India won.

#### Deepika Scores the winning goal

- The only goal in the final match was scored by the Indian player Deepika, which turned
- out to be the match-winning goal.
- Despite missing a penalty stroke, Deepika scored in the third quarter of the match to put
- India 1-0 up. The Indian defence held its ground during the remaining period of the
- match despite continuous counterattacks by the Chinese team.
- The win puts the India team in the same league as South Korea, the most successful team in the tournament, with three titles each.
- India defeated Japan 2-0 in the semifinal, and China defeated Malaysia 3-1.



# 8th Women's Asian Champions Trophy 2024 Participants

- The Women's Asian Champions Trophy is played using the same format as the Men's
- Asian Champions Trophy. The top six ranked Asian women's hockey teams participate in
- the Women's Asian Champions Trophy Hockey Tournament.
- This year, teams from India, Japan, China, Thailand, Malaysia, and South Korea
- participated in the tournament.

### **Women's Asian Hockey Champions Trophy**

- The first Women's Asian Champions Trophy hockey tournament was held in 2010. Since the third Women's Asian Hockey Championship, the men's and women's Asian Champions Trophy hockey tournaments are held in the same year.
- South Korea and India are the most successful teams, having won it three times each, followed by Japan, which has won it twice. The Indian team has reached the finals of the tournament five times.

The first India-CARICOM summit meeting was held on the sidelines of the 74th Session of the United Nations General Assembly meeting on September 25, 2019,

- The 2nd India-CARICOM summit meeting was held in Georgetown, Guyana, on 20 November 2024.
- Co-Host of the Summit: Narendra Modi and Dickon Mitchell, Prime Minister of Grenada and Chair of the Conference of Heads of Government of CARICOM.
- The meeting was attended by the leaders of the 14 CARICOM countries. No representative of Haiti was present during the Summit Meeting.
- During his speech, the Prime Minister proposed seven key pillars to strengthen the ties
- between India and CARICOM C for Capacity Building, A for Agriculture and Food
- Security, R for Renewable Energy and Climate Change, I for Innovation, Technology and Trade, C for Cricket and Culture, O for Ocean Economy and M for Medicine and
- Healthcare. India will host the third India-CARICOM Summit meeting in 2025.

- the Treaty of Chaguaramas to promote economic integration and relations between Caribbean countries.

- commemorates the arrival of the first ship carrying Indian indentured labourers in
- **4** 1838.
- He addressed the special sitting of the Country's Parliament called the National
- Assembly.
- He addressed the Indian diaspora in Georgetown. Around 40 % of the Guyana
- population are of Indian origin, who were brought to the country to work in the
- sugarcane field after the abolition of slavery.
- Prime Minister Modi held state-level talks with Dr. Mohamed Irfaan Ali, the President
- of Guyana, and discussed issues of mutual importance.

- States.

#### About the ASEAN Defence Ministers' Plus

- The ASEAN Defence Ministers' Plus Forum is an extended group of ASEAN and resident powers of the region who are also known as dialogue partners. They are Australia, China, India, Japan, New Zealand, South Korea, Russia and the United States.
- It aims to strengthen security and defence cooperation amongst the countries of Asia
- Pacific to promote peace, stability, and development in the region.
- The first ADMM-Plus was convened in Hanoi, Vietnam, in October 2010.
- From 2017 onwards, it has become an annual meeting to discuss security and other
- regional challenges.
- The ADMM-Plus currently focuses on seven areas: maritime security, counterterrorism.
- humanitarian assistance and disaster management, peacekeeping operations, military
- medicine, humanitarian mine action and cyber security.

- Army by the President of Nepal, Ramchandra Paudel, at a special ceremony at the
- President's House in Kathmandu on 21 November 2024. The Nepali President is the commander in chief of the Nepali Armed Forces.

# Highlights of the General Upendra Dwivedi Visit

- It was General Upendra Dwivedi's first official visit to Nepal after being appointed the 30th
- Chief of the Indian Army.
- His five-member delegation includes his wife, Sunita Dwivedi. The Army Chief's wife has
- always been the Chairperson of the Army Wives Welfare Association of the Indian Army.
- He held talks with Nepal's Chief of Army Staff (COAS), General Ashok Raj Sigdel, at the
- Nepali Army headquarters in Kathmandu.
- General Upendra Dwivedi gifted military horses and dogs to General Ashok Raj Sigdel.
- He also planted a Rudraksha sapling on the premises of the Nepali Army headquarters.

### **India Nepal Military Ties**

- The East India Company recruited Nepal's Gurkha into its army and used them in its
- various campaigns.
- Even after the power transfer from the East India Company to the British Crown in 1858.
- the tradition of recruiting the Gurkhas continued under British India rule.
- This tradition was continued after India's independence in 1947. A tripartite agreement
- was signed between India, the British government, and the Nepali government in 1947.
- The agreement split the Gurkha regiment serving in British India into the Indian Army
- and the British Army.
- The recruitment of Nepali citizens in the Indian Army continued after independence.
- After the introduction of the Agniveer scheme in the Indian Army, Nepal stopped the
- recruitment of Nepali citizens in the Indian Army.
- There are around 88,000 retired Indian Army personnel living in Nepal.
- Despite the ban on recruiting Nepalis for the Indian Army, both armies have continued
- joint training.
- The Indian Army continues to provide training to Nepalese Army personnel and also
- sends its personnel to undergo training in Nepal.
- Both the countries conduct a joint military exercise code-named Surya Kiran. Nepal will
- host the 18th edition of the Surya Kiran in Nepal in December 2024.
