The result of Common Entrance Examination 2026 held on 07/06/2026 for admission into B.Sc. Nursing, D.Pharm, B. Pharm and Allied and Health Care courses for admission into both public and private institutes of Assam has been declared and made available in the official website of the University www.ssuhs.ac.in.

The candidates can download their score card w.e.f. 18-07-2026 against the course opted at the time of submission of online application by using their Application ID and Password.

The candidates who opted biology as their choice of subjects in the OMR Sheet shall be provisionally eligible for B.Sc. Nursing/ D. Pharm /B. Pharm/ Allied and Health Care courses and the candidates who opted mathematics as their choice of subject in their OMR Sheet shall be provisionally eligible for D. Pharm/ B. Pharm/ Bachelor in Anaesthesia and Operation Theatre Technology/ Bachelor of Optometry courses if they fulfill the other eligibility criteria including minimum eligibility score in the CEE (Percentile) and the respective admission guidelines of the concerned regulatory councils.

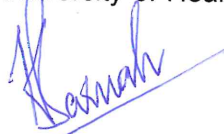
